

IPPR FEES FOR MEMBERSHIP AND LICENSE TO USE THE PSV TRADEMARK

The General Assembly of the shareholders has approved the following annual contributions:

1) Membership (annual fee) *

Conditions: the contribution is requested following the application for membership, and then on an annual basis. For memberships from 01/01 to 30/06 the entire contribution will be requested while for those from 01/07 to 31/12 50% of the contribution will be requested.

Members are **entitled to withdraw** from the Institute, after two years from registration, by registered letter, to be sent by September 30th. The withdrawal will take effect at the end of the calendar year.

2) Contribution for the license to use the Plastica Seconda Vita (Plastic Second Life) trademark (annual fee)

Conditions: The contribution is requested annually and only following the completion of the PSV trademark certification procedure. It is independent of the number of certified products and turnover relating to the sale of the same.

For the first year, the contribution will be requested in relation to the actual months of possession of the certification.

Any renunciation of the trademark entails payment of the full fee for the current year.

3) Contribution for the license to use the Plastica Seconda Vita (Plastic Second Life) trademark (Chain of custody certification)

Conditions: The contribution is requested annually and only following the completion of the PSV trademark certification procedure according to the provisions of paragraph 2.18 "Certification of the supply chain". It is independent of the number of certified products and the turnover relating to their sale.

For the first year, the contribution will be requested in relation to the actual months of possession of the certification.

Any renunciation of the trademark entails payment of the full fee for the current year.

For companies that proceed for the first time in 2026 with the membership and/or license to use the Plastica Seconda Vita (Plastic Second Life) brand, the contributions will be reduced for the first year by 30% and for the second year by 15% compared to the quotas determined annually.
