# Ambitions Cirular Plastic Packaging

- Valipac stimulates the use of circular plastic packaging in Belgium: (A circular packaging is a packaging with a minimum percentage of post-consumer recycled content)
- Valipac wants to grant a financial bonus to its customers who market circular plastic packaging in Belgium.
- The My Recycled Content project will start on 1 January 2022.





# 'My Recycled Content' – The Project

**Description:** The aim of this project is to monitor and to increase the use of recycled content (plastic) in single use commercial and industrial packaging. Therefore, Valipac develops a meeting place where interested companies can get in touch with companies that offer plastic packaging containing minimum 30% recycled plastic <sup>(1)</sup>.

Who? All companies selling goods on the Belgian market (packaging responsible type A, B or C) and who are Valipac clients.

**Bonus:** 50 € per ton of recycled PCR (2) plastic used in C&I packaging placed on the Belgian market. The bonus amount is annually reviewable.

Start of pilot: project: Q1 2022

Bonus payments: Q1 2023 (3)

- (1) It is not the intention that companies can place orders via this website.
- (2) Post-consumer material, i.e. waste from selective collections from businesses >< PIR post-industrial material, i.e. production waste.
- (3) he bonus granted may be revised after an audit based on purchase invoices.

This platform is an initiative of Valipac in collaboration with Fema, PMC and Fédération Belge de la Brique, aiming to promote the use of commercial and industrial packaging made from recycled plastics by bringing together suppliers and professional users.













- Via this platform, suppliers (manufacturers or wholesalers) promote their range of commercial and industrial packaging containing recycled plastics.
- Users can consult the various types of commercial and industrial packaging made from recycled plastics available on the market.

#### Why make or use commercial and industrial packaging containing recycled plastics?

When we use packaging containing recycled plastics, we do more than just avoid extracting natural resources. Recycling one tonne of plastics also avoids the production of 3.03 tonnes of CO2.

Using recycled plastics in our commercial and industrial packaging also boosts recycling in Europe and local job creation.









# My Recycled Content – Packaging Vendor

- 1. The producer or vendor of circular packaging signs up on the "My Recycled Content" website... and accepts the 6 commitments in the charter.
- 2. The vendor of circular packaging fills in the requested information, including the certificate proving the percentage of recycled content.
- 3. After validating the information, Valipac releases the information on the website and making it visible to all companies looking for packaging containing recycled plastic.





#### As a manufacturer or wholesaler, I undertake to respect the following 6 commitments:



I offer my customers packaging made from post-consumer recycled plastic (PCR).



As a producer I follow, during the design phase, Design for Recycling guidelines. As a wholesaler I request my packaging manufacturer, during the design phase, to follow Design for Recycling guidelines (RecyClass is recommended).



As a producer I work with EuCertPlast certified (or equivalent) recyclers. As a wholesaler I request my packaging manufacturer to work with EuCertPlast certified (or equivalent) recyclers.



As a producer I apply Post Use Recycled materials (according to ISO 14021) in my plastic packaging materials. As a wholesaler I request my packaging manufacturer to apply Post Use Recycled materials (according to ISO 14021) in his packaging materials.



As a producer I have circular packaging materials certified by an accredited certification body and I have a copy of the certificate. As a wholesaler I request the producer to have his packaging materials certified by an accredited certification body and I have a copy of the certificates.



I inform Valipac / myRecycledContent about changes in the specificities of my circular packaging (% R content...) and about new circular packaging put on the Belgian market by my company

As a supplier, you must have a certification of the PCR share by a certification system recognized by PolyCert.





# My Recycled Content – Circular Packaging Buyer

- 1. A buyer in search of circular packaging:
  - 1. Visits the website and accesses a reliable database of circular packaging.
  - 2. Finds the desired packaging material, makes contact with the vendor and closes a deal (if appropriate).
- 2. The circular packaging buyer (\*):
  - 1. Reports once a year to Valipac the amount of single-use commercial and industrial packaging placed on the Belgian market with its percentage of recycled content.
  - 2. Valipac, after verifying the input, pays out the bonus in the form of a deduction from the annual Valipac contribution.

# My Recycled Content - Bonus Calculation

- 1. Example: You have purchased shrink-wrap containing 50% recycled material. The total weight of these shrink-wraps is 20 tonnes.
- 2. 60% of this packaging is intended for the Belgian market (40% for export).
- 3. Your bonus: 20 tonnes \* 60% = 12 tonnes of which 50% is recycled material = 6 tonnes \* 50€ = 300€.
- 4. Have you put less than one tonne on the market? The minimum bonus amount is 50€.





# My Recycled Content: the Valipac offer

## What does Valipac offer?

- A reliable database of vendors and producers of certified circular plastic packaging.
- Traceability of the use of certified recycled plastic in Belgium.
- The opportunity for vendors to showcase their circular packaging for free on an open to all website.
- The vendors and buyers (users) of circular packaging are given permission to use the 'Approved Circular Company' logo in their internal and external commu





# My Recycled Content: Valipac R&D support



Valipac assumes the role of catalyst for its customers and brings the right partners around the table to initiate and maintain circular projects.

Valipac has already demonstrated with projects that mobilize the total value chain that circular packaging can fulfill its technical role.
